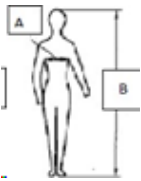


The garment made of 100% Polyester Knitted fluorescent fabric in yellow or orange-red and retro-reflective band in grey color meets the requirement of harmonized standard EN ISO 20471:2013+A1:2016 Class 2. Fulfill PPE regulation EU 2016/425 CAT II



Class 2, Minimum area of visible material:

- background material 0.50 m²;
- retro-reflecting material 0.13 m²

Usage and Limitations:

The garment is high visibility warning clothing only, is intended to provide conspicuity of the wearer in any light condition when viewed by operators of vehicles or other mechanized equipment during daylight conditions and under illuminations of headlights in the dark. This garment is conspicuity aid. Garment to be worn under scarce day light visibility conditions and at night with vehicle head lights on.

The wearing of a conspicuity-enhancing high visibility garments does not guarantee that the wearer will be visible under all conditions.

The garment does NOT provide any protection against e.g. chemical hazards, heat and fire, cold, electricity or other type of risk

The garment should be worn over trouser waistbands and not tucked in at all times to provide the correct level of protection as stated above. Keep retro reflective tape outwards when worn.

Inspect your garment before each use. Check for cracks, frayed straps, fading and any signs of damage. Replace the garment immediately if you notice any signs of wear, damage, abuse or environmental degradation. Do not repair by yourself. The visibility characteristic of the garment can be altered in case they have not been adequately clean or have undergone unauthorized modifications.

Always wear the garment fastened at all times and keep clean. The safety feature is only guaranteed if garment being worn is of the correct size and is fastened correctly.

Storage:

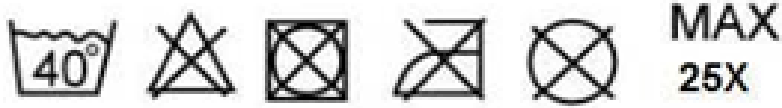
Do NOT store in places subject to direct strong sunlight. The garment should be stored in its original packing, in a cool, dry clean place. Keep the original package for transport.

Max. washing temperature 40
